Please note: We are obliged by HMRC to make it clear that £1,400 of the £1,750 for the Society of Londoners membership and £4,500 of the £5,000 paid by Visionaries are voluntary donation components. It is possible to purchase membership without making this donation, at a cost of £350 or £500, respectively.



Direct Debit Guarantee (this should be detached and kept by the Payer)

- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit, the Museum of London will notify you 20 working days in advance of your account being debited or as otherwise agreed. If you request the Museum of London to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by the Museum of London or your bank or building society you are entitled to a full and immediate refund of the amount paid from your bank and building society – if you receive a refund you are not entitled to, you must pay it back when the Museum of London asks you to.
- You can cancel your Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify the Museum of London.
