What will be covered?

Collections review enables a museum to improve its understanding of a collection so that it can be used more effectively. Collections reviews are often the first stage of rationalising collections, which can lead to the *Deaccessioning and disposal* of objects. However, there are many other reasons to review collections. These include understanding the significance of your holdings; identifying opportunities to develop under–used collections; getting new insights into what your users find interesting about your objects; and planning future research, use and collections care.

In this session Sarah Brown, Collections Trust, will introduce different methodologies and frameworks, and introduce the new *Collections Review* procedure from the recently updated Spectrum standard, Spectrum 5.0. In the afternoon we will explore the legal and ethical considerations for *Deaccessioning and disposal*. Delegates will be encouraged to participate through discussions and activities, and there will be plenty of opportunity for questions throughout.
