What will be covered?

This training course is designed for museum professionals who wish to develop the skills and knowledge required to reopen a museum after a sustained period of closure. These sessions will utilise guidance provided by museum associations, advisory bodies and central government. A programme for reopening will be discussed and developed which will be informed by case studies for UK and International institutions, including the Museum of London. The course will focus on practical measures and potential solutions to known and expected post lockdown restrictions such as social distancing, cleaning, visitor experience, staff welfare etc.

The adaptation of museums to enable people to visit or work whist socially distanced, may have some unforeseen effects on collections and their care. In the second day we will look at some of the issues which might need to be considered such as cleaning, new routes through the building and object handling and what can be done to mitigate risks to staff, visitors and the objects themselves.

Who should attend?

This course is aimed at museum professionals with responsibility for museum operations and facilities management.

Whilst being delivered in a virtual format the session will be interactive with the opportunity for ongoing Q&A as well as polling, networking, group work and other interactive content.
